The Ross Property Owners' Association (RPOA) was formed in the 1960's and presently has 325 Ross households as members and a Board of five Ross citizens.

The RPOA's charter is to help the Town of Ross by improving Town property and by sponsoring community improvement events to help make Ross a great place to live.



RPOA annually receives over 300 contributions. These funds are used for projects and events as follows:

- Construction of two light posts for the Town Commons
- Contribution to remodeling the Post Office
- Contribution to landscaping around Town Hall
- Construction, installation, ongoing placement of colorful banners in downtown area
- Construction and placement of new bulletin board kiosks
- Purchase and installation of bike racks in front of Post Office
- Christmas and 4th of July decorations throughout the Town
- Tree and bush trimming of lot at Sir Francis Drake & Lagunitas
- Installation and maintenance of "Eddie's Tree" in front of our Post Office
- Installation and ongoing replacement of "Doggie Bags" at Town Commons
- Sponsoring "Candidate Nights" during elections
- Sponsoring First Aid preparedness classes at Ross School

Town Ordinance Regarding Right-of-Way Maintenance

Fall is here and with it comes a greater need for attention to detail regarding the right-of-way on our property line. The Town provides clarification that "all occupants and owners of property within the town are required to maintain the section of right-of-way from the property line to the edge of the road pavement". Further, "maintenance shall include removal of leaves and weeds which shall be disposed of away from the site...Maintenance of all landscaping shall be the responsibility of the property owners". Similar ordinances are in place for maintaining the driveway culvert (Chapter 12.10) and drainage ditches (Chapter 13.16) in front of or within your property.

10 For those who are interested in further reading on the maintenance of trees, RPOA directs you to Chapter 12.24 entitled "Planting Alteration, Removal or Maintenance of Trees." Section 12.24.040 discuss-es trees in the public right-of-way. Pruning, maintenance and removal of trees greater that 1" in diameter located in the right-of-way shall be performed by contractors who have on staff a certified arborist or other qualified person approved by the Town Manager or designee.

RPOA—BayWood Artists Plein Air Benefit Show at MAGC

The BayWood Artists just celebrated their 20th Anniversary at the Marin Art and Garden Center on the weekend of October 6th with an art show featuring about 100 original plein air landscape paintings. They partnered with One Tam and had a very successful event, raising \$36,000 which they shared with One Tam.

One Tam is the Tamalpais Lands Collaborative Community Engagement Initiative. They have supported mountain-wide youth and community programs, restoration activities and citizen science opportunities. Their efforts benefit the increased stewardship of Mt. Tam's resources. This is the second year they have partnered with the BayWood Artists.

The BayWood Artists is a non-profit plein air group founded in 1997 when Mary Welch, then Founder and Director of the landscape show Marinscapes, suggested to Zee Mott, Lissa

Nicolaus and Sherrill Miller that they form a plein air painting group. The group's goal was to benefit the environment and bring attention to endangered lands through their artwork. Since then, countless volunteer hours have gone into producing these annual art shows and the small group of artists has tirelessly strived to bring awareness to many different organizations.

Some of the organizations that BayWood Artists has benefitted are: Save the Bolinas Lagoon, San Anselmo Open Space, Golden Gate National Recreation Area, Marin Open Space, Marin Baylands Advocates, Golden Gate National Parks Association, Tamalpais Conservation Club, Bay Model Association, Marin Conservation League, Russian River Keepers, Marin Agricultural Land Trust, Angel Island Association, Save Mount Diablo, Point Reyes National Seashore Association, and Farallon Marine Sanctuary.

What a tremendous service they have provided to our community and the nature that we so cherish!

The RPOA looks forward to contributing to the enhancement and renovation of the Park and to improving the access to the Phoenix Lake and Mt. Baldy area and to all of Mt. 

Mount Tamalpais stands adjacent to the Ross community and is core to the natural heritage of Marin. Although Mt. Tam's plants and wildlife live in protected open spaces, the mountain's health is threatened by invasive species, habitat fragmentation, plant diseases, and pollution. At the same time, the number of visitors has multiplied to about 6 million people per year.

The non-profit agency "One Tam" provides unprecedented opportunities for the various land managers of Mt. Tam to work together with the community to care for this beloved place at a mountain-wide scale in the face of these threats, and is helping renew the spirit of philanthropy that has been so fundamental to Mt. Tam's preservation over the past century.

One Tam priority projects include forest, trail corridor, creek and wet land wet land restoration.
